Clovelly Pilot Gig Club Safeguarding Policy for Children and Vulnerable Adults 28 Feb 2024

Clovelly Pilot Gig Club has a moral and legal obligation to ensure that anyone participating in their sport can do so in a safe environment, especially children and vulnerable adults. All coaches and volunteers must ensure they give the highest standard of care and act in accordance with the club's protection policy.

The club's policy follows and aligns with the Cornish Pilot Gig Association's overall protection policy, a copy of which is available on the club's Teamer site.

Clovelly Pilot Gig Club will ensure that it provides quality opportunities for young people and vulnerable adults.

- The welfare of the individual is paramount
- All children and vulnerable adults whatever their age, culture, disability, gender, language, racial origin, religious beliefs, and/or sexual identity, have the right to be protected from abuse
- All suspicions and allegations of abuse will be taken seriously and responded to appropriately
- All coaches and volunteers have a responsibility to report concerns of abuse to the club's Safeguarding Officer

Recruitment of coaches and volunteers.

All adults involved in working with children or vulnerable adults in a paid or unpaid capacity will be subject to a number of checks to ensure their suitability.

All **coaches** will be required to:

- Undertake a Disclosure and Barring Service (DBS) check
- Attend training including first aid and safeguarding children and vulnerable adults
- Become suitably qualified as a coach or produce certificates if already qualified
- Ensure they are insured through British Rowing to oversee training sessions

Volunteers will be required to undertake a DBS check

Photography

If at any time coaches wish to use photographic or video equipment as a coaching aid, parents and young people will be made aware that it is a part of the coaching programme and how the footage will be used and stored.


Responding to allegations

It is not the responsibility of any coach or volunteer at the club to decide whether or not abuse has taken place. However, it **is** their responsibility to act on any concerns or allegations by referring them to the club's Safeguarding Officer, who will pass details to the relevant authority. To report any concerns about suspected abuse within the club follow the process in appendix 1.

Appendix 1: Flow Chart for Reporting a Concern

If you are concerned about possible abuse or bad practice Record the facts (see appendix 2) and keep the information confidential Is the Club Safeguarding Officer implicated?

If a child or vulnerable adult needs **immediate medical attention**, call an ambulance and ensure the paramedic knows there is a protection concern
